## Comp Threshold One of a Kind

The threshold established last year by the Legislature for determining permanent total disability awards from the Workers Compensation Fund places West Virginia as the only state in the country with such an eligibility requirement.

Testifying before the workers' compensation subcommittee of the Joint Standing Committee of the Judiciary on November 13th, the Workers Compensation Funds Director of Research and Informa-

tion Judith Greenwood told lawmakers "We appear to stand alone in respect of having a threshold for qualifying for permanent total disabilities."

According to West Virginia AFL-CIO President Joe Powell the state's solitary position on the disability threshold is new evidence of the unfairness of the legislatures actions last year.

"Now we know how mean it was," Powell said.

# Resolution Passes in 24 Counties

ACT Legislative Representative B.B. Smith has been criss-crossing the state urging County Commissions to pass resolutions supporting the hiring of local workers on projects which are publicly funded. These resolutions will demonstrate the need for legislation such as the West Virginia Jobs Act which would require projects funded by state tax dollars to hire ninety percent of the workers locally. The Jobs Act is one of ACT's primary legislative goals for next year.

"Our objective right now is to gain support for important components of the Jobs Act at the county commission level," Smith said.

Twenty-four counties have already passed the resolution. They are Doddridge, Ritchie, Harrison, Raleigh, Clay, Wirt, Lincoln, Hardy, Grant, Preston, Marshall, Tucker, Fayette, Wood, Wetzel, Lewis, Wayne, Taylor, Calhoun, Randolph, Wyoming, Nicholas, Braxton and Tyler.

In the coming weeks resolutions will be taken up in Boone, Cabell, Mason, Monongalia, Kanawha, Webster, Summers, Berkeley, Monroe, Roane, Barbour, Greenbrier and Gilmer counties.

Only two counties, Putnam and

Jackson, have rejected the resolution.

"By and large the support is very strong for local jobs," Smith said, "The county officials understand, just as we do, that tax-funded projects which hire local workers help build stronger communities. They see the recklessness of letting these jobs go to people not living in the area."

ACT members in counties which have not yet taken action on the resolution are encouraged to contact their County Commissioners and urge their support of this measure.


